PART SEVEN

BUNK-IN PROGRAM QUALIFICATION REQUIREMENT

The following are requirements of applicants to be eligible for the Moyers Corners Bunk-in Program.

1. Applicant must be a full member of a volunteer fire Department within New York State who shall act as their sponsor.
2. Applicant must be cleared to Interior Firefighter Status by their sponsored Fire Department.
3. Applicant must provide a letter from their sponsoring Fire Department Chief that the Applicant is cleared to interior status and successfully completed New York State Firefighter I; provide with application.
4. Applicant must provide Certificate of Insurance from their sponsoring Fire Department for Workers Compensation Coverage; provide with application.
5. Applicant must be eighteen (18) years of age prior to June 30th or the beginning of the College Semester
6. Applicant must be a High School Graduate (or GED) prior to June 30th.
7. Must have successfully completed New York State Firefighter I prior to May 31st.
8. Applicant must be a full time matriculated student in a college program within Onondaga County or a contiguous County.
9. Applicant must sign the Bunk-In Contract and provide \$250.00 refundable room deposit at time of interview.
10. The Applicants will undergo a Physical by the Moyers Corners Fire Department Physician during Orientation. The Applicant must successfully pass the Physical and be cleared to Interior Status to remain in the Program.
11. Applicant must successfully pass the Moyers Corners Fire Department Probationary Training Program to remain in the Program.
12. See the attached Bunk-In Contract for more specific and additional responsibilities and requirements.
